## **DIGITAL PRICES**

ILG now offers digital (electronic) copies of the above publications (except for the executive summary tabs), with pricing determined by volume.

<b>Number of Copies</b>	Price Per Copy
Two to five copies	\$5 each (\$25 for whole set)
Six to 25 copies	\$3.50 each (\$17.50 for set)
26-75 copies	\$2.50 each (\$12.50 for set)
76 or more copies	\$1.50 each (\$7.50 for set)

**Example #1:** County A wants to order five digital copies of the set of ethics publications. The cost would be  $5 \times $25 = $125$  plus tax or \$100 less than buying the hardcopy set. If County A also wants to order the executive summary tabs to help assemble the notebooks for its five recipients, it can do so for  $5 \times $2.50 = $12.50$ , for a total publication price of \$112.50 (plus tax and shipping and handling charges for the tabs).

**Example #2:** City B wants to order 10 digital copies of *Promoting Personal and Organizational Ethics*. The cost would be  $10 \times 3.50 = 35$ , plus sales tax and shipping and handling charges.
