OFFICERS

Dan Whitehurst, Chair. Dan is a retired businessman who served as mayor of Fresno from 1977-1985 and was President of the League of California Cities' Mayors and Council Members Department. A graduate of Saint Mary's College of California and UC Hastings College of the Law, he also holds an M.A. in Urban Studies from Occidental College. He was a Coro Fellow in Public Affairs and a Resident Fellow of the Institute of Politics at Harvard University. He is a member (and past chair) of the board of directors of the California State Automobile Association (AAA). Dan and his wife Kathleen live in St. Helena.

Hal Conklin, Vice Chair. Hal currently serves as the public affairs director for the Southern California Edison utility company's northern region.
