





## First Amendment 101

"Congress shall make no law ... abridging the freedom of speech ...."

- Applies to local agencies through 14<sup>th</sup> amendment
- Doesn't have to be a "law"





### **Threshold Issue**

Is a *public agency* abridging speech?

 Individual blog by public official, not created with public resources: probably not

Public agency blog, created with public resources: yes





### **Key Issues**

### What kind of forum?

- Traditional websites-Not a public forum

– Interactive – May well be a public forum

What kinds of limits?





## Limits

### • Allowed:

Topic specific (within the subject matter jurisdiction or defined topic)

### Not allowed

- Deletions of objectionable remarks
- "Objectionable" may include some profanity









### **Brown Act Issues**

- AG: Email exchanges = meeting
- Discussions on blogs or any exchange of info on positions = meeting







### **Brown Act: Implications**

- Being FB friends: OK
- Grandkids picture comments: OK
- Substantive issues: Not OK





## **Brown Act Implications**

- Use web 2.0 media to supplement practices
- Not supplant
- Ex: Agenda postings/ teleconferencing



### Best Practices for Elected Officials



- Use social media to seek input
- Not broadcast one's views in advance of meeting





## **Guidance to Employees**

- Public capacity: Consider guidelines (ex: Utah)
- Private capacity: Be aware of right to speak on issues of public concern
