Who can participate?

Eligible customers must receive a rebate or incentive through a qualified SoCalGas energy-efficiency program and have an active SoCalGas account for the past two years for the location/facility. The account must be in good standing, with no deposit on record, and no disconnect notices in the last twelve months. Project payback based on projected annual energy savings must be ten years or better for Taxpayer-Funded Institutional Customers and five years or better for Non-Institutional Customers.
