### Why It's Important

Forests, parks, agricultural lands and open space serve as "carbon sinks" by storing greenhouse gas emissions that otherwise contribute to climate change. Other benefits include jobs and economic activity from agriculture, recreation and tourism; better health from physical activity and access to fresh local food; and a higher quality of life and more attractive communities for businesses and residents.

- In 2007 Santa Clarita property owners voted for the [Open Space Preservation District](#) which is funded through a special assessment on property owners.
- The Town of Apple Valley is working with state and federal wildlife agencies to create a new [Multispecies Habitat Conservation Plan](#).
- The City of Chula Vista has adopted [Climate Adaptation Strategies](#), committing the City to ensuring that its open space and wildlife preserves are resilient to expected climate change impacts.
- The City of Santa Barbara conducted a [Tree Inventory and Assessment Report](#). The data received will allow the City to effectively manage resources, develop policies, and set priorities.
