Registration Information

Registration is online using the Child Nutrition Information and Payment System (CNIPS). The instructions are different for Child Nutrition sponsors versus those who are not Child Nutrition sponsors. Please review the instructions below *before* starting the registration process.

Instructions for Child Nutrition Program Sponsors

1. Obtain your agency's five-digit CNIPS ID number *OR* personal User ID and password.
2. Access the CDE CNIPS Web page at https://www.cnips.ca.gov/ccgCnpTraining/training/trainingRegistration_2.aspx to connect to CNIPS and begin the online registration process.
3. Use your agency's CNIPS ID or personal User ID and password to register and follow the system prompts as shown below:
 - a. Program Training Available screen - select "All"
 - b. Available Training screen - select "Nutrition Education Forum-2013"
 - c. Available Training Location screen - select preferred location
4. After completing the Attendee Information and **before** selecting the finish button and exiting the system, **print the Training Confirmation** (last screen in the online registration process). This is your **ONLY** record.

Instructions for Other Registrants

1. Access the CDE CNIPS Web page at https://www.cnips.ca.gov/ccgCnpTraining/training/trainingRegistration_2.aspx to connect to CNIPS and begin the online registration process.
2. Select "View Available Trainings" on the first screen.
3. Enter your agency or company name in the sponsor name box (if you do not work for an organization, enter your last name in this box).
4. Register following the system prompts below:
 - a. Program Training Available screen - select "All"
 - b. Available Training screen - select "Nutrition Education Forum-2013"
 - c. Available Training Location screen - select preferred location
5. After completing the Attendee Information and **before** selecting the finish button and exiting the system, **print the Training Confirmation** (last screen in the online registration process). This is your **ONLY** record.
