

- In March 2020, standard Brown Act teleconferencing requirements were waived or modified by the Governor's Executive Orders and AB 361, which took effect on October 1, 2021.
- AB 361 required public agencies to find that a proclaimed State of Emergency still exists, and find either of the following:
 - (1) that state or local officials continue to impose or recommend measures to promote social distancing, or
 - (2) that as a result of the State of Emergency, meeting in person would present imminent risks to the health or safety of attendees.
- The COVID-19 State of Emergency was terminated on February 28, 2023, meaning that AB 361 teleconferencing will be unavailable moving forward unless another State of Emergency is declared.

Brown Act – Teleconferencing



- 2 Potential Options:
 - Pre-Pandemic Rule
 - "Just Cause" or "Emergency Circumstances" (AB 2449)
- Notes:
 - All are in Government Code 54953
 - Only applies to legislative body members, not staff or consultants

Brown Act – Pre-Pandemic Teleconferencing



- Classic Rule Still Applicable
 - You must:
 - > Give your location on the agenda
 - > Post an agenda at the site
 - > Allow public access to the site
 - > Take rollcall vote
 - You do not have to:
 - > Have video
 - Allow public to teleconference
 - Potentially can have multiple public sites.
 - Quorum must be in jurisdiction, but not in a single place
 - What if no board members shows up to remote location?



- AB 2449 Limited Teleconferencing
 - No need to post location if other requirements are met.
 - Requirements:
 - Physical Location. A quorum must participate from a single physical location within the agency's jurisdiction
 - Video. The meeting must have either two-way video (e.g., Zoom) or telephone with live webcasting
 - > Notice/Participation. Agenda must show how public virtually participates
 - > Public Comments. Must allow during meeting; cannot limit to advanced comments
 - > Technical Difficulties. Must stop meeting if on agency's end



Must have valid reasons for teleconferencing:

- Only two justifications:
 - Just Cause
 - Childcare or family caregiving need (limited to certain family)
 - Contagious illness
 - A need related to physical or mental disability
 - Travel while on official business of the legislative body or another state or local agency
 - Medical Emergency
 - Physical medical emergency that prevents in-person participation
 - Family medical emergency that prevents in-person participation



Notification Requirements

- Just Cause
 - Notice to legislative body at earliest opportunity
 - > Must give general description of reasons
- Medical Emergency
 - Must make request of legislative body at earliest opportunity
 - Legislative body must take action to approve request
 - Can be added as a late item by 2/3 vote
 - Must give general description of reasons
 - Do not have to disclose confidential medical information



Limitations

- Just Cause
 - > No more than two meetings in a calendar year
- AB 2449 generally
 - > No more than three consecutive months or 20% of meetings within a calendar year.
 - > If less than 10 meetings a year, no more than two meetings.



Participation Requirements

- Must disclose whether anyone 18 or older is present in the room
- Disclose general nature of relationship to those in room
- Must use both audio AND visual technology

Some Agencies have adopted policies that they will not use AB 2449



• In Sum:

- Provides a limited basis to participate virtually if the official gives a reason and appears on video, and the legislative body approves participation.
- The legislative body must have the capability to provide audio and visual technology and enable public participation virtually.



- Consider adopting a policy to implement
- Consider stating on the agenda when the virtual participation option is being provided only for the convenience of the public and is not required by law
- Other best practices and recommendations




IN-PRACTICE EXPERIENCE WITH NEW HYBRID MEETING REQUIREMENTS

- Government Code Section 54953 (1994)
- COVID rules AB361
- Current legislation AB2449
- Future AB817

VERNON'S HYBRID MEETING ADOPTION

- Prior to COVID-19 only audio recording
- Currently Hybrid Public Comment in-person or via Zoom
- Utilized AB2449 during LAUSD strike (childcare provision)
- July 1 Discontinuing use of Zoom unless under AB2449



SAMPLE HYBRID MEETING MINUTES

Mayor Lopez called the meeting to order at 9:00 a.m. She indicated that, pursuant to Government Code Section 54953(f), with a quorum of the City Council present in the Council Chamber at City Hall, she would be participating remotely under the just cause provision due to the need to care for her children during the LAUSD strike; that there was no one over 18 years of age in the room with her at her remote location; and that she was participating via Zoom webinar with both audio and video capabilities.


