Retirement Celebration Planning: Looking for Ways to Avoid Another Rubber Chicken Dinner and Plaque? The Institute for Local Government's Legacy Fund Can Help

Demographics being what they are, a number of our colleagues are contemplating retirement. While visions of more time for such activities as travel, gardening, fishing and getting more exercise are enticing, there tends to be one final hurdle to overcome before we ride into the sunset: the obligatory retirement/tribute dinner, with the associated presentations of plaques, resin encased badges, proclamations and other items that may be hard for us to find a use for or a place to display.

For some, this rite of passage may contain great meaning and the plaques and other items will have sentimental value. Others may be searching for an alternative.

For those in the latter category, we have an idea for your consideration. If you are aware of an intent to collect for a gift or the your agency plans to do a plaque, consider requesting a contribution to the Institute Local Government's endowment fund in lieu of a gift, plaque or full-scale retirement event. It enables the community and your colleagues to recognize your public service with a contribution in your honor. It also demonstrates your own ongoing commitment to public service and making sure local officials have resources to support them in their service to their communities.

For example, many agencies that organize retirement events pay for them by charging attendees a certain amount, so there is no backlash about using taxpayer monies for this purpose. Typically the cost of any gift for the retiree is built into this per person charge. Let it be known that you appreciate the thought of such a celebration, but you would like any money that would otherwise be spent on items to be presented to you to be instead used to support the cause you feel most strongly about: good government at the local level.
