Email comments on matters not on the agenda must be submitted prior to the time the Mayor calls the item for Public Comments. Email comments on agenda items must be submitted prior to the time the Mayor closes public comments on the agenda item. All email comments shall be subject to the same rules as would otherwise govern speaker comments at the Council meeting. Electronic comments on agenda items for the March 24, 2020 Council meeting may only be submitted via email and comments via text and social media (Facebook, Twitter, etc.) will not be accepted.
