AB 1661 Sexual Harassment Prevention Training



We are partnering with the League of California Cities and Renne Public Law Group on an **AB 1661 Sexual Harassment Prevention Training Webinar.** AB 1661 requires local agency officials to receive two hours of sexual harassment prevention training and education within the first six months of taking office and every two years thereafter if the agency provides any type of compensation, salary or stipend to those officials.



The League and Institute for Local Government recommend that city officials consult with their city attorney to confirm this webinar satisfies the requirements of the local agency.
