ILG is grateful for our partnership with the California Department of Housing and Community Development Department (HCD), the Governor's Office of Planning and Research (OPR) and Placeworks to provide training and technical assistance to local agencies on this issue.

Working Together for Cleaner Air and Stronger Communities



This year, ILG has worked closely with the <u>San Joaquin Valley Air Pollution Control District (SJVAPCD)</u> in the cities of Shafter and Fresno to help achieve the goals of AB 617, which will advance ongoing state and District efforts to reduce regional and community exposure to air pollutants. ILG is facilitating the community-led process and recently both Steering Committees hit a major milestone by adopting their Community Emissions Reduction Program plans. We are grateful to the Air District, the community stakeholders and CARB for partnering with ILG and we congratulate them on their important work and ongoing collaboration on this

issue. As Shafter and Fresno move into a multi-year implementation phase, additional AB 617 communities will be announced in December.

Foundational Training for Exceptional Leaders

California's local governments face a myriad of challenges from housing and homelessness, to climate change, to budget shortfalls to aging infrastructure. Elected leaders and staff cannot effectively address these challenges without a strong foundation of good government - trust, accountability, responsiveness and transparency. Each year, ILG hosts dozens of trainings and publishes numerous written resources to help local government leaders build that foundation, develop



leadership skills and increase public trust. Our <u>law firm partners</u> are instrumental in this effort and we're grateful for their expert counsel in this area.
